However, Learning by Design evaluated its community engagement opportunities and determines that civil rights organizations, tribes and other advocates are neither present nor served by Learning by Design Charter School.

ESSER III Expenditure Plan Instructions

Introduction

- Written in an understandable and uniform format;
- Written in a language that parents can understand, to the extent practicable;
 - If it is not practicable to provide written translations to a parent with limited English proficiency, the plan must be orally translated for parents
- Provided in an alternative format to a parent who is an individual with a disability as defined by the Americans with Disabilities Act, upon request; and
- Be made publicly available on the LEA's website.
